## Annual Campaign – Doug Wentz

## Grants - Ted Neal

- Jump Street
  - A grant award was received in the mail for \$1636. This is an increase over the 2017 grant of \$1472.
  - Additional paperwork from us is needed by 10/31, but the paperwork, consisting of a PDF form, has not yet been emailed to us. I have emailed Melissa Snyder concerning the email. The Arts Council has been late in finalizing PDF forms previously, so I am not particularly concerned.
- Tyco grant for risers.
  - We still have had no response positive or negative concerning our April request. I emailed them again requesting feedback.
- Schlegel Deibler Charitable Foundation Inc
