- PPP loans
  - o HGMC is an eligible organization
  - Members 1<sup>st</sup> no longer accepting loan requests and would not provide information
  - HGMC does not have eligible payroll to request loan for.
    - 1099 contractors not eligible expense. Clearly answered in FAQs at the SBA website.
    - Confirmed with my business accountant and with my business banker, Orrstown Bank.
  - No application made

- o If we did not pay contractors, they would individually be eligible to apply.
