



### **Waiver of Liability, relevant to the coronavirus/COVID-19, while participating in HGMC functions**

I acknowledge that the Coronavirus/COVID-19 is contagious, and that public health authorities recommend practicing social distancing to avoid exposure to the virus, except for persons who have been fully vaccinated.

I understand that I may increase my risk of exposure to the Coronavirus/COVID-19 by participating in HGMC functions, like rehearsal, performances, retreats, and other functions (hereafter referred to collectively as "functions".)

I acknowledge that HGMC makes no guarantee that I will not become infected with the Coronavirus/COVID-19 if I choose to participate in an HGMC functions. I assume all risk associated with participation if I choose to participate in an HGMC function.

I understand that to reduce risk to members, HGMC requests that only fully vaccinated persons participate in events, until such time that the pandemic has ended.

I will comply with any CDC recommendations and/or any PA Department of Health regulations regarding masking, social distancing, or other infection control measures, which are in effect at the time of the event.

I will not participate in an HGMC function if any of the following apply to me:

- I experience any symptom of illness related to the Coronavirus/COVID-19 such as a cough, shortness of breath or difficulty breathing, fever, chills, myalgias, headache, sore throat, or new loss of taste or smell, and have not had a negative covid test since the start of the symptoms.
- I have been diagnosed with Coronavirus/COVID-19 and not yet been cleared as non-contagious by my physician, or a state or local public health authority.
- I am on quarantine for exposure to Coronavirus/COVID-19, as required by CDC guidelines, state or local public health authority.
- I am not fully vaccinated against Coronavirus/COVID-19.

I further acknowledge that, if I participate in an HGMC function, I do so voluntarily.

I hereby release and agree to hold the Harrisburg Gay Men's Chorus, its employees, agents, representatives, board of trustees, board members, heirs, successors, and assigns, harmless from, and waive on behalf of myself, my heirs, and any personal representatives, any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss of income resulting from exposure to the Coronavirus/COVID-19 that may be caused by any act, or failure to act, or negligence by HGMC staff, contractors, or volunteers, or that may otherwise arise in connection with by participation in an HGMC function. I understand that my signature on this release discharges the Harrisburg Gay Men's Chorus from any liability or claim that I, my heirs, or any personal representatives may have against HGMC with respect to any exposure to or infection from, the Coronavirus/COVID-19, including illness, death, medical treatment, or loss of income, that may arise from, or in connection to my participation in an HGMC function.
