- Annual review of books The 2016 books were given to Kyle Junk, who was appointed by the board to review
 them. His report was reviewed at the last board meeting. The following changes have been made:
 - o Paypal is no longer being used for recurring payments on GoDaddy.
 - o Deposit summaries are now being filed with the deposit slips
 - Accounts will be aligned to the new budget cagetories after the books are closed for 2017.
- GALA refunds Nothing further since last board meeting.
- Annual campaign see separate report by Doug Wentz/Kyle Junk
- Fundraising Arrangements are in process for the February fundraiser. The fundraising committee will finalize details.
- Royalties update. We should be reporting and paying to three PRO's: BMI, ASCAP and SESAC. ASCAP membership an email request for contact was sent last month. I did receive an email contract which expired before I could review and sent it back. Contact was made again and an annual contract is in the mail from them. The annual fee will be \$245, per calendar year. No information on SESAC yet. The chorus apparently already has a Tresona account, but I cannot access it. (Tresona does custom arranging fees and some video and sound recording licenses.)
- Recordings Nothing new.
- Life storage rental box has been paid through end of January 2018. Moving to a new facility is currently on hold.
- Voice United payments and accounting is completed with \$796.08 to Pride Fest of Central PA, however it hasn't been cashed yet.
