

Harrisburg Gay Men's Chorus Board Meeting Minutes February 18, 2018

- 1) Call to order: The meeting was called to order at 7:10 PM by President Kyle Junk.
- 2) Additions/Deletions to the Agenda:

3) Approval of January 21st Meeting Minutes

- Approval of the January minutes was proposed by Bob R. and seconded by Bill with all voting in favor.

- 6) **Executive Session** This is an off-the-record portion of the meeting where board members can speak freely about their concerns. No official business is decided.

7) Unfinished Business

•

- Purchase of a Digital Piano.
 - The piano is set up at Bob R.'s residence. Bob noted that the piano should have a carrying case. Steve noted that since we are under budget for the piano, Bob R. can investigate purchasing a case without the need for an additional motion from the board.
 - Details about the piano and accessories are in the treasurer's report.
 - Relocation/Upgrade of Storage Unit.
 - Bob N. reported that Mechanicsburg Storage on Simpson Ferry Rd has a 10x15 unit for \$85 per month. There will be no administration fee if the person signing and securing the site wears a non-profit organization t-shirt. This low fee includes first month free and 10% off the normal rental cost.
 - Bob N.'s also investigated potential east shore locations. The Storage Depot on Milnor Road has no available 10x15, only a 10x25 for \$264/month. Storage Depot on Allentown Blvd has a 10x15 for \$125 per month, plus a monthly \$25 admin fee.
 - The board agreed to select Mechanicsburg Storage beginning March 1 if the location is still available. It also agreed to keep the existing location through March 31 to allow a workable transition period.
 - The new location requires an increase in the annual storage budget. Steve proposed, and Doug seconded a motion to increase the annual budget for storage to \$1200. All voted in favor.

• Washington D.C. Gay Men's Chorus Co-concert (3/24/18).

- Bob R. distributed a proposed press release to announce the event.
- Doug noted the lack of any input or assistance from the LGBT Center itself.
- Doug will contact David Payne from Radio Pennsylvania about potential publicity.
- Steve will contact Penn Live about running an article in exchange for an advertisement bought by HGMC.
- Doug proposed, and Ted seconded a motion to spend \$50 for a Facebook post of the event.

- Steve proposed, and Bill seconded a motion to raise the publicity budget from \$50 to \$250.
- Purchase of Risers
 - This item was tabled until March.
- Community Outreach: Sharing Our Caring.
 - HGMC will sponsor this for Monday March 13.
 - Tom attended the February event, spoke with the people who attend, and reported to the board, and the board decided on the following:
 - To adhere to health standards, all necessary cooking will be done in the commercial kitchen at MCC of the Spirit, where the event is taking place.
 - Those assisting with the cooking should arrive by 3:00 PM.
 - The menu will consist of meat loaf, gravy, mashed potatoes, coleslaw, salad, and coconut cake, with macaroni-and-cheese as an alternative entrée.
 - The meal will be at 6:00, with chorus members serving and invited to share in the meal. Rehearsal will be in the MCC Chapel after the meal.
 - Doug proposed, and Steve seconded a motion to sponsor this meal, inform the chorus members, and to allocate up to \$250 to support the effort if necessary.

8) New BusinessHight

- Highmark Walk for a Healthy Community.
 - Kyle suggested HGMC come up with a team to walk at this event on Saturday, May 19. Money raised by HGMC would go to support "Common Roads", a LGBT youth group sponsored by the Central PA LGBT Center.
 - Doug proposed, and Tom seconded a motion to authorize Kyle to sign up walkers from HGMC who will be responsible for walking on May 19 and collecting donations for Common Roads. All voted in favor.
- Standard Operating Procedures.
 - The board agreed a collection of standardized procedures should be developed to help future board members assume roles.
 - Doug circulated a template to be used to document procedures, and example procedure for creating a fundraiser, and suggested topics for which procedures should be developed. The documents were greeted favorably.
 - It was suggested that board members develop procedures as they perform their duties.
